Job Summary

The Registered Nurse (RN)/Licensed Practical Nurse (LPN) provides compassionate, traumainformed nursing care to individuals receiving substance use and mental health treatment. The LPN supports patients through medication management, health monitoring, and education, working closely with the multidisciplinary care team to promote recovery and overall well-being.

Core Responsibilities

- Administer medications, including MAT (Medication-Assisted Treatment) such as methadone, buprenorphine, or naltrexone, in accordance with medical orders and program protocols.
- Monitor patients for withdrawal symptoms, side effects, and adverse reactions, escalating concerns to the RN, physician, or prescriber as needed.
- Conduct intake assessments including vital signs, health history, and risk screenings.
- Support medical providers in treatment planning and ongoing patient care.
- Provide patient education on medications, harm reduction, infection control, and health promotion.
- Document all nursing care, interventions, and patient responses accurately in the electronic health record (EHR).
- Maintain medication logs, controlled substance counts, and follow DEA, state, and clinic regulations.
- Respond to medical and psychiatric emergencies with professionalism and adherence to protocols.
- Foster a safe, respectful, and stigma-free environment for patients in recovery.
- Collaborate with counselors, case managers, peer support specialists, and other members of the care team.
- Participate in team meetings, quality improvement activities, and ongoing staff training.
- Other duties as assigned.
