OUR HISTORY

Townhall II began as two separate, grassroots entities – a crisis line housed on the campus of Kent State University during the 1967-68 academic year and shortly thereafter a community based drop in center conceived by a group of volunteers who wanted to provide immediate help to those in need, and make a positive impact on the drug culture of the era. The two efforts combined and the organization was incorporated in 1971, providing Portage County, Ohio, with services focusing on drug education, emergency assistance in crisis situations, and medical diagnosis and treatment.

Over the years, Townhall II grew in response to community needs and expanded services offered to include substance use disorder counseling, services for victims of traumatic crime, and prevention programming. In 1997, Townhall II merged with Portage County Alcohol and Drug Abuse Services and increased substance use disorder treatment programs, a Halfway House for women in recovery from substance abuse and addiction, and a DUI school for first time offenders.

More recently, Townhall II has opened a Medication Assisted Treatment clinic, and added peer support and case management services. Townhall II has proudly served the community for 50 years.

Program Highlights

988 Suicide and Crisis Lifeline

Townhall II was designated to answer 988 calls through our helpline for all of Portage County. Since July 16th, we have received 177 total calls through 988 and 29 priority calls which required a first/safety responder.

Townhall II's 50th Anniversary.

On the evening of May 20th, Townhall II celebrated its 50th Anniversary with an evening dinner, presentations, and awards at Northeast Ohio Medical Center. It was wonderful to see so many community members celebrate with us! Winners of the awards included the Mental Health and Recovery Board of Portage County, Karyn Kravetz, Sarah McCully, Lateace Lee, and James A. Garfield Local School District.

Gambling Prevention & Treatment Grant

Townhall II received a grant of \$50,000 from OHMHAS for gambling prevention and treatment. With this money we started a telehealth problem gambling group. Bill Newberry, our gambling treatment counselor, created a curriculum and served three people with this group. Next step is to open the group up to people around the state who are in need of group treatment for problem gambling.

Portage Sexual Assault Response Team (SART)

Our first SART meeting was held on July 21st, 2021. The team aims to develop and maintain guidelines and protocols to prioritize victim's needs, hold offenders accountable, and promote safety and support to all victims. The team also educates the community on intervention and prevention services available throughout the county.

Let's Talk About It

Our Mothers in Recovery Support Group started October 4th, 2021. The space provides moms in recovery with a safe, understanding and judgement free platform. The peer led group allows the members to discuss any important issues that they are facing and how to overcome barriers. The group was nominated for the Health Initiative Award through Celebrate Portage.

Program Highlights

Case Management Services

Townhall II added case management to the vast array of services we provide. Case managers play a vital role in assisting people in recovery. Any client at Townhall II in treatment may request this service. Case managers can help with accountability for recovery programs, referrals and connections to community services, advocacy with local resources, education to understand prescriptions, billing, & budgeting, and assistance or referrals for transportation needs.

Childcare for Treatment Groups

With the help of an alcohol use disorder grant from OHMAS, we began providing child care for clients in group. Child care workers are available during group times in order to minimize barriers for parents. In FY2022, 10 parents took advantage of this.

Signs of Suicide (SOS)

Townhall II is proud to be able to provide the evidenced-based Signs of Suicide Prevention Program to Middle and High School students throughout the county. We were able to serve 264 students and are projected to serve more than 800 students next year!

Streetsboro Youth Led Projects

The High School group's major focus was making everyone feel included and as if they had a place in the school. When you enter Streetsboro High School, you are welcomed by a staircase mural depicting both present and former students and faculty. Several photographs of students participating in sports, organizations, academics, and activities are displayed throughout the school. The students highlighted each club and organization through banners displayed throughout the school.

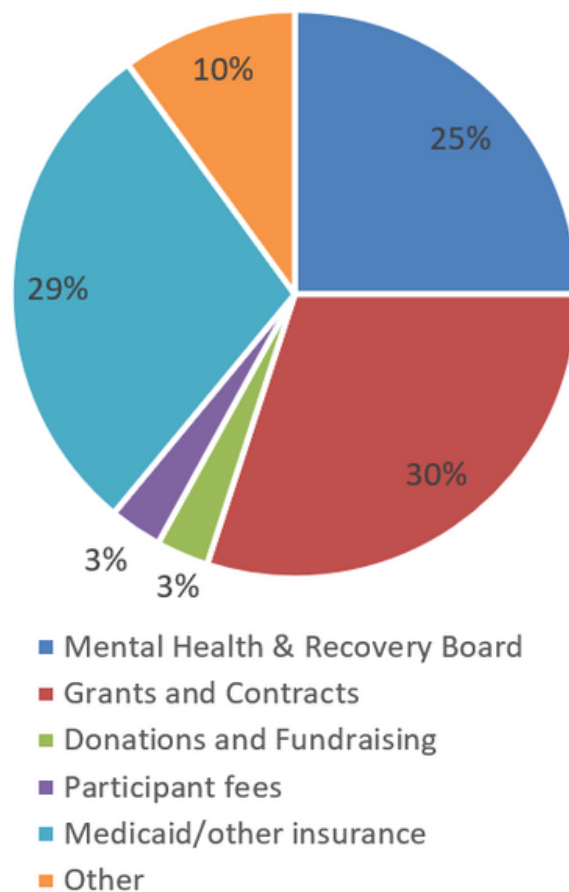

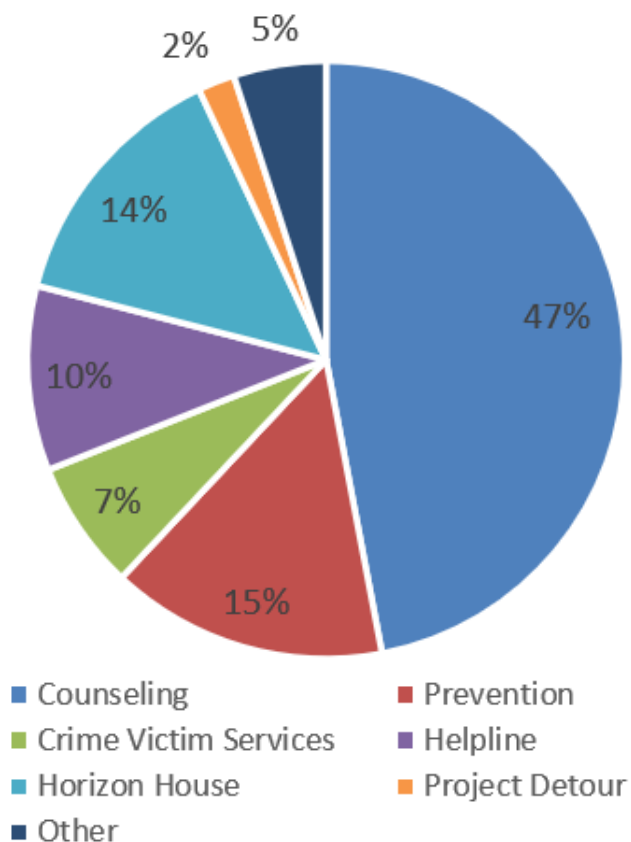
