Our History

Townhall II began as two separate grassroots entities – a crisis line housed on the Kent State University campus during the 1967-68 academic year, and a community-based, drop-in center conceived by a group of volunteers who wanted to provide immediate help to those in need and make a positive impact on the drug culture of the era. The two efforts combined and the organization was incorporated in 1971, providing Portage County, Ohio, with services focusing on drug education and emergency assistance in crisis situations, as well as medical diagnosis and treatment.

Over the years, Townhall II grew in response to community needs and expanded services to include substance use disorder (SUD) counseling, services for victims of traumatic crime and prevention programming. In 1997, Townhall II merged with Portage County Alcohol and Drug Abuse Services and increased SUD treatment programs, opened Horizon House, a halfway house for women in recovery from SUDs and Project Detour, a driver intervention program for first-time offenders of driving under the influence.

More recently, Townhall II has opened a Medication-Assisted Treatment (MAT) clinic and added peer support and case management services. To-day, we continue to expand our services in response to community needs with our mission and vision statements guiding us.

The agency hosted its first Community Picnic in downtown Kent with an estimated 300 attendees.






Townhall II COMING SOON

March 2024

Dr. Amanda Burke, Townhall II's Problem Gambling Prevention Specialist was honored posthumously at the Problem Gambling Network of Ohio's annual conference with the Award of Excellence. TH2 completed a brand update with a new logo and a new name, Townhall II Integrated Health Network.



of our offices.










Grand opening for Townhall II Integrated Health Network's newest location at 512 N. Chestnut in Ravenna.










Program Highlights

Counseling

732 individuals were treated for alcohol and/or drug dependency.

328 individuals were treated for mental health issues.

552 Intensive Outpatient groups (IOP) were held. These groups are designed for people who don't need 24-hour supervision or medical detoxification, but still require more care than outpatient treatment can provide. These groups focus on developing and maintaining abstinence from alcohol and/or other drugs, increasing the client's understanding of addiction and how to effectively manage the disease and identifying strengths and barriers to recovery.

166 Continuing Care groups were held. These groups are maintenance groups that focus on monitoring and maintaining abstinence, addressing relapse issues as they occur, developing a relapse prevention plan, becoming more involved in support group meetings and developing a recovery lifestyle.

22 Integrated Dual Disorder Treatment (IDDT) groups were held. These groups are for people with co-occurring disorders of substance use disorder and a mental illness. The group builds structure and focuses on increasing and understanding both disorders and how they affect one another, developing and maintaining abstinence from all mood-altering substances, how to effectively manage both disorders and identifying strengths and barriers for dual recovery.

43 IDDT Relapse Prevention groups were held. For people who have been through IDDT, the focus of this group is monitoring and maintaining abstinence from all mood-altering substances, monitoring and maintaining consistent use of psychotropic medications as prescribed, developing a dual-recovery lifestyle, addressing any relapse issues as they occur, developing a relapse prevention plan, building a sober support system and practicing recovery tools.

18 Problem Gambling groups were held. For people who have been identified as having a gambling problem. The group focuses on understanding gambling addiction while building a network of peers to talk about individual struggles. It also helps people to identify and avoid gambling triggers and building a relapse prevention plan.

43 Connections groups were held. This group is geared towards the specialized dockets of the HOPE and RISE courts of Summit County. The group focuses on identifying shame triggers and expanding critical awareness while using a model promoting shame resiliency.

Crisis Helpline

521 Helpline calls

206 988 calls

Top Primary Concerns for Helpline calls were: mental health, relationship concerns, inappropriate contacts and physical concerns.

Top Primary Concerns for call to 988 were: mental health, suicide/self harm, relationship concerns and substance use.

3 calls to Helpline (0.006%) resulted in calling emergency services to send to the caller or person of concern.

6 calls to 988 (0.029%) resulted in calling emergency services to send to the caller or person of concern.

Program Highlights

Horizon House

Townhall II's residential treatment home for women hosted 43 clients. Of those, 33, or 77 percent, successfully completed treatment. The national average is 49 percent (2022 Treatment Episode Data Set from the Substance Abuse and Mental Health Services Administration).

Medicine-Assisted Treatment (MAT) Clinic

As a part of our holistic approach to health, wellness and recovery, the Townhall II MAT Clinic uses medications, combined with counseling and the support of family and friends, to help people sustain recovery. These medications help reduce cravings, effects of the drugs and reduce the risk of relapse. Our clinic offers daily, weekly and monthly treatment options with medications for opioid-use disorder (MOUD) and alcoholism to eligible patients.

79 ongoing patients were served in FY2024.

58 patients received harm-reduction counseling and were offered harm-reduction supplies during their in take assessment. All patients have access to harm-reduction supplies and counseling during each visit. These same supplies are offered to all Townhall II clients during business hours.

66 patients were provided nicotine patches.

Project Detour

Project Detour is a 72-hour, residential, state-certified driver intervention program for individuals, 18 years and older, with a first-time OVI offence (operating a vehicle while under the influence of alcohol and/or drugs) and it is certified by the Ohio Department of Mental Health and Addiction Services. In FY 2024, the program hosted 209 clients, four of which did not successfully complete the program.

Victim of Crime Advocacy and Portage County Rape Crisis Center

Townhall II is Portage County's Rape Crisis Center and provides services to victims of crime. Services include a 24-hour Crisis Helpline (330-678-HELP), in-person advocacy and support, and free and confidential counseling by counselors trained in working with survivors dealing with trauma, anxiety, depression and stress.

During FY2024, the Portage County Rape Crisis Center served 88 survivors. Victimizations included past and current child physical/sexual assault and neglect, domestic violence, adult sexual assault/rape, elder abuse, sexual harassment, robbery, stalking and adult physical assault.

Program Highlights

Prevention Education

"Too Good for Drugs" is designed to mitigate risk factors and enhance protective factors related to alcohol, tobacco and other drug use. It was presented to 2,796 elementary to high school students at 11 local school districts.

"Project Alert," addressing the pro-drug mindset of today's teens and increasing their likelihood to remain drug free, was presented to 986 middle school students at 10 local school districts.

"Stand Up" teaches students to become aware of sexual assault, positive behavior skills that promote safe relationships, individual and self-respect, consent and active bystander interventions. It was presented to 2,192 students in middle school through high school at 10 local school districts.

"Personal Body Safety" teaches students how to identify potential abuse, how to assert one's body rights, how to tell an adult when self-protection is not possible, and what to do if abuse is witnessed. It was presented to 5,176 kindergarten through elementary school students at XX Portage County school districts. We also taught 2,305 students outside of Portage County.

"Signs of Suicide" is a suicide prevention program that educates students about the relationship between suicide and depression and how to ACT (Acknowledge, Care and Tell). It was presented to 1,001 middle and high school students at five different school districts.

Substance Use Online Education Diversion Courses about vaping and marijuana were presented to 94 high school and middle school students at four Portage County school districts. The same classes and additional classes about alcohol and nicotine use were provided to 79 individuals in Portage County Juvenile Court. Alcohol and marijuana classes were provided to 43 students at Kent State University.

"Problem Gambling" was presented to 793 middle and high schools students at six local school districts.

"Active Parenting" provides information on effective parenting for parents of children 5-12 years old. It was presented to 52 area parents/guardians/caregivers.

"Parenting Wisely" aims to improve parenting skills, reduce adolescent behavior problems and enhance relationships between parents and teen children. 20 area parents/guardians/caregivers took this class.

Mothers in Recovery support group served 26 individuals.

17 community tabling events were attended where information was distributed and Townhall II staff had interactions with more than 5,000 people.
